Boarding rates for dogs kenneled for showing purposes only: \$10.00 per day.
Boarding rates for dogs not being shown: All non-show dogs \$20.00 per day.

Other Terms and Conditions:

1. All telephone calls to the dog's owner(s) will be made collect.
2. If a dog is to be boarded for handling purposes, a \$500.00 deposit will be required.
3. Airport charge to pick up or deliver is \$100.00at Dayton; Columbus or Cincinnati is \$150.00 per trip.
4. Breeding Charges for females sent in to breed is \$75.00.
5. A special charge may be required for dog's first grooming when it enters the kennel for show purposes.
6. All veterinarian charges will be billed monthly at cost.
7. All entries are entered on Entries on Time Service. If I send in an entry fee service charge will be \$6.00 per entry.
8. Nina Fetter will bill the dog's owner on the last day of each month; if payment is not received by the 15th of the following month, a 21% late charge will be added to the unpaid balance each month

9. All checks for handling, boarding, and entry fees should be made payable to Nina Fetter.
10. If a dog is entered and not shown because of inconvenience or personal reasons, the owner will be billed for normal amount of show and board.
11. The handler will be permitted to use her discretion when she has two clients' dogs for Winners, Group, or Best in Show.
12. All coated dogs will be charged a \$50.00 weekly conditioning fee, enhancing fees \$50.00 weekly, and stripping fees \$50.00 per week. Note: All fees are quoted per breed size and prices may vary.
13. Depending on amount of conditioning the dog needs, a service charge will be added.
14. In case, handler cannot make the ring, a qualified handler will take the said dog into the ring.
15. For all circuits the hotel & gas expenses will be divided between clients equally (circuit consisting of 5 or more shows).
16. Nina Fetter provides a monthly bill listing each charge rendered by show and dog; however, if there are any questions, notify us promptly, so that any discrepancies can be resolved please.
17. A retainer for entries being made by the handler is required. Amount \$500.00. This will be applied to last statement.
18. Owner agrees handler shall not be responsible for illness, death, or loss of dog unless by handler's negligence.
19. All accounts have a credit limit of \$1,500.00, once any of this amount is past due; it is our discretion if you're dog gets shown.
20. For any non-sufficient checks a \$25.00 service charge is added to you're account and my service charges from my bank.
21. All road expenses are pro-rated or .45 cents per mile.
22. Any account turned over for collection will be charged all court cost, legal fees, and collection fees.
23. All clients' dogs that reside with me (full-time dogs) always have preferred status at shows over ringside pick-ups or part time clients.
24. A permanent record for each client must be signed and be accompanied by this rate sheet, my contract, and limited power of attorney must be on file with Nina M. Fetter, before she can show your dog or take possession of your dog.
25. A first time veterinarian appointment will be made for each dog being brought into the kennel for his/her career. This will be paid by the owner.
26. Prize money awarded in the ring is the property of the handler.
27. Any invitational show, nationals, or special arranged shows will be quoted on per individual basis.
28. A monthly Postage Expense will be automatically billed to each client of \$20.00 per month for tear sheets, ribbons, and trophies.
29. As of July 1, 2008: A fuel sur-charge is added per weekend for the fuel to and from the show and divided by the number of client dogs shown that weekend
30. As of January 1, 2007: A service charge for all credit card usage will be added to your account. American Express is 5% and Visa and MasterCard is 3%.

I accept MasterCard, Visa, Discover, which will have a 3% service fee added, and American Express, which will have a 5% service fee added to each billing.
